## Wii Rent Shipping Policy

For prospective Wii Rent clients who require Wii Rent services outside of San Diego, these clients may review the Wii Rent Shipping Policy to determine their eligibility to have Wii Rent ship rental equipment to them.

Prospective clients can contact Wii Rent ([shiprequest@wiirent.com](mailto:shiprequest@wiirent.com)) for a rental quote should the following criteria be met:

- For shipping, Wii Rent rental equipment is **limited** to the following equipment (bundled as the Wii Rent **Wii Ship Package**):  
[Wii Console](#) | [Audio/Video/Power cables](#) | [Sensor Bar](#) | [Four Wii Remotes](#) | [Two Nunchuks](#) | [Two games](#)
- Large additional accessories (such as Rock Band/Guitar Hero instruments or Balance Boards) cannot be shipped. Small accessories such as Wii Motion Plus adapters may be shipped when required.
- Wii Sports game disc will be provided with every **Wii Ship Package**. Additional game of client choice is provided free by Wii Rent if Wii Rent has the game in its rental inventory, with the exception of Wii Sports Resort. A fee of \$15 will apply to each game Wii Rent does not have in its rental inventory and will acquire to meet the needs of the rental. Wii Sports Resort with (4) Wii Motion Plus adapters will also incur an additional \$15 charge.
- Eight 'AA' batteries to power the four Wii Remotes can be supplied by Wii Rent for an additional \$10.00.
- Multiple **Wii Ship Packages** may be reserved and shipped.
- The client is based within the 48 contiguous US states.
- The client has permission from the intended event venue to utilize Wii Rent supplied equipment. Wii Rent will not provide a refund should the venue refuse to permit Wii Rent supplied equipment to be used.
- The client has sufficient technical capabilities to set-up and operate Wii Rent supplied equipment. Troubleshooting assistance by Wii Rent is provided on a 'best efforts' basis. A quick-start guide to setting up rental equipment will be provided by Wii Rent, and links to Nintendo Manuals can be found on the on-line [Wii Rent FAQ](#).
- The client is recommended to provide Wii Rent at least 14 days notice before the first day of the rental. Shipping charges may increase should less than 14 days notice be provided.
- Rental fees must exceed \$250, not including shipping or security deposit. The daily rental fee of a single **Wii Ship Package** is \$50.00. Any rental calculated to not meet the minimum \$250 rental charge will be priced at \$250.
- One-way only insured shipping from Wii Rent to client will be \$25 per **Wii Ship Package**. Wii Rent will invoice the client for the shipping charge and rental fees. Full payment must be made and the Rental Agreement signed and returned to Wii Rent before rental equipment will be authorized for shipment.
- For return shipping of rental equipment the client is to organize with their preferred shipping vendor. Client agrees to ship **Wii Ship Package** rental equipment back to Wii Rent to arrive within five business days from the end of the rental period at client cost. Client to arrange shipment insurance for \$300 per **Wii Ship Package**. **Wii Ship Package** rental equipment not received by Wii Rent within five business days will incur a charge of \$50.00 per day until received.
- A security deposit of \$250 per **Wii Ship Package** via credit card authorization will be applicable.

Should the criteria be met, Wii Rent will consider equipment availability and other factors to determine if a shipped rental is an option. A potential Wii Rent client meeting the above criteria does not guarantee a rental can be accommodated.
